#### 1 PRESIDENTS REPORT

#### Strategic Review (February 2022)

In our annual strategic review, we have refreshed our strategy and mission to ensure our purpose aligns with the overarching goals of the health reforms as well as responding to consistent member feedback on the need for greater impact through advocating for the industry to achieve our purpose. Our new mission is as follows:

# 'To be the voice of the Med-Tech industry, influencing change and advocating for the critical role medical technology plays in improving health outcomes for all New Zealanders and a thriving economy.'

The new mission reiterates:

- That we are the 'voice' of the med-tech industry.
- We will 'influence change' through improved government affairs and advocacy activities.
- We are committed to 'improve health outcomes' through the use of medical technology.
- We act for 'all' New Zealanders in reference to the government's goal to reduce health inequities for target groups such as Māori, Pacific and disabled people.
- Med-tech's contribution to a 'thriving economy' in NZ.

A key development in the strategy is to have a greater focus on advocacy and government policy, which Cushla will speak to. The Board are committed to developing our expertise and impact in regulatory, market and investment access that affect our industry strengthen the Advisory Groups structure and focus. I recognise that this could not be possible without the contribution of knowledge, time and expertise from member companies in this area. The goal of MTANZ is utilise this contribution for all to have a strong and consistent impact. The board recognises the contribution of many individuals, with support of their organisations, to the associations work.

## **MTANZ Member Survey Results**

The results of the survey show that the current MTANZ activity members value most highly is 'providing relevant sector and industry information'. When asked what services would be most valuable in the future, 'advocacy and lobbying' was unanimously named as the most important service MTANZ can offer to members. The survey results and rapidly changing health landscape fed into the decision to realign the MTANZ structure and resources to focus more on 'Government Affairs and Policy'.

## **Market Access Group**

#### Advocacy

Alongside the work to futureproof our structure and strategy, there was a lot of engagement with government due to the many new laws passed through parliament and the Pharmac Review, therefore MTANZ made several med tech specific submissions as part of our advocacy work for members. The submissions include:

- Pae Ora (Healthy Futures) Bill,
- COVID19 Public Health Response Amendment Bill
- Pharmac Review submission

#### **Key Messages**

Health Technology Assessments (HTAs)

• MTANZ recommend that HTAs sit within HNZ and the MHA, accountable to the Ministry of Health, to ensure integration and alignment with the relevant equity and health target strategies.

#### Innovation

- The Introduction of a Rapid Access to Medical Technology Scheme This is relevant for patients with significant unmet medical needs for target health groups or where treatments address serious or life-threatening conditions.
- Horizon Scanning for Technology Innovation This scanning is an embedded feature of the NICE approach in the UK, the NZ government should consult the technology sector on innovation as part of a formalised structure to ensure the New Zealand system can capitalise on advances to address healthcare deficiencies and disparities. If the onus is on HNZ and MHA to improve health outcomes, this function should sit with these entities.

Focus on Patient Outcomes

- New legislation presents the opportunity for greater weighting to be placed on patient health and well-being outcomes and to broaden Pharmac's statutory objectives to include societal benefit. New legislation should ensure that all health entities including Pharmac engage with healthcare consumers sufficiently early in assessment and planning processes to ensure a genuine, nontokenistic consultation occurs.
- Value based health procurement principles should be integrated into MBIE Government Procurement Guides and Rules of Sourcing.
- HNZ and MHA's data and digital systems should be commissioned to capture patient outcomes to facilitate Value Based Health Care implementation. This includes the ability to support decentralised care closer to home, the integration of innovation and technology, enhanced collaborative care and access to comprehensive and reliable healthcare data
